## INTRODUCTION

- 1.1 This manual is published pursuant to sections 14 and 51 of the Promotion of Access to Information Act 2 of 2000 ("**PAIA**") which was promulgated in order to nurture an ethos which promotes transparency, accountability and effective governance of all private and public bodies. PAIA gives effect to section 32 of the Constitution of the Republic of South Africa, 1996, which provides for the right of access to information in a manner that affords persons a means/platform to obtain the records of private and public bodies as promptly and as efficiently as reasonably possible to endorse, including but not limited to, mechanisms and procedures that empower and educate all persons.
- 1.2 PAIA requires organisations to compile a manual as a guide to requesters of information. The Manual also serves to indicate the types of records held by the Automatrix Proprietary Limited ("**AutoMatrix**") and the availability of such records from Automatrix.
- 1.3 In addition, the manual explains how to access, or object to, or request correction or deletion of, personal information held by Automatrix, in terms of sections 23, 24 and 25 of the Protection of Personal Information Act 4 of 2013 ("**POPIA**"), and the Regulations Relating to the Protection of Personal Information, 2017 ("**POPIA Regulations**").
- 1.4 This manual is not exhaustive of, nor does it comprehensively deal with, every procedure provided for in PAIA. Requestors are advised to familiarise themselves with the provisions of PAIA and POPIA before making any requests to Automatrix in terms of these Acts. However, in terms of section 19 of PAIA, and Regulations 2 and 3 of the POPIA, Automatrix will provide such assistance as is required in completing the necessary forms, by parties applying for access to information or personal information.
- 1.5 Automatrix makes no representation and gives no undertaking or warranty that the information in this manual or any information provided by it to a requestor is complete or accurate, or that such information is fit for any purpose. All users of any such information use such information entirely at their own risk, and Automatrix will not be liable for any loss, expense, liability or claims, howsoever arising, resulting from the use of this manual or of any information provided by Automatrix or from any error therein.

1.8 As of 1 July 2021, the Information Regulator will assume the functions of the South African Human Rights Commission (“**SAHRC**”) and will be responsible for PAIA and POPIA queries.

1.9 As part of its functions, the Information Regulator will publish a guide on how to use PAIA and POPIA in the new dispensation. The Information Regulator has not yet published a guide to this effect.

## **PROCESSING OF PERSONAL INFORMATION**

### 2.1 POPIA

2.1.1 Chapter 3 of POPIA provides for the minimum conditions for lawful processing of Personal Information. These conditions may not be derogated from unless specific exclusions apply as outlined in POPIA.

2.1.2 Automatrix processes personal information in accordance with POPIA. In terms of our privacy policy, , Automatrix will ensure that all processing conditions of POPIA are complied with at the time of processing of personal information. Automatrix processes personal information of both living and juristic persons.

### 2.2 Purpose for processing of personal information by AutoMatrix

As stated in our privacy policy, Automatrix processes personal information for a number of reasons including, but not limited to, –

- 2.2.1 providing requested services;
- 2.2.2 managing the commercial relationship with customers;
- 2.2.3 manage dispute resolution;
- 2.2.4 create and manage supplier relationships;

- 2.2.5 manage contracts, orders, deliveries, invoices and accounting;
- 2.2.6 sending quotation estimates;
- 2.2.7 processing and managing customer subscriptions;
- 2.2.8 collect statistical information and run analytics in order to improve services understand customers better (the extent of which Werksmans is unaware);
- 2.2.9 general human resource and finance functions including those obligations imposed by legislation;
- 2.2.10 sending marketing communications and managing a list of customers who wish to not receive marketing material; and
- 2.2.11 to allow proper functioning of the website which includes, amongst others, proper display of content, interface personalisation and ensuring that the website is safe and secure to protect against misuse.

### 2.3 Categories of data subjects

Automatrix processes personal information relating to the following categories of data subjects –

- 2.3.1 customers (particularly vehicle owners);
- 2.3.2 shareholders;
- 2.3.3 board of trustees;
- 2.3.4 beneficiaries;
- 2.3.5 directors;
- 2.3.6 employees and job applicants;
- 2.3.7 juristic entities (i.e. service providers, contractors, consultants, body repairers)
- 2.3.8 complainants and enquirers;
- 2.3.9 visitors to premises;
- 2.3.10 individuals captured by CCTV images; and

2.3.11 individuals who have an interest in the products and services of Automatrix.

2.4 Types of information (and special personal information) processed

2.4.1 As stated in our privacy policy, Automatrix processes the following types of personal information, amongst others, –

2.4.1.1 name and surname;

2.4.1.2 email address and postal address (invoicing);

2.4.1.3 phone number;

2.4.1.4 transaction information (details regarding the service subscribed, transaction number);

2.4.1.5 services history;

2.4.1.6 payment information;

2.4.1.7 data relating to the commercial relationship and details regarding the service subscribed (including duration and any correspondence);

2.4.1.8 vehicle details, including VIN and registration number, vehicle model and year or registration, insurer details, replacement parts purchases (including description, supplier and cost), vehicle write-off information);

2.4.1.9 job cards, quotations and billing data; and

2.4.1.10 information collected by cookies or similar technologies.

2.4.2 Please refer to our Privacy Policy for further information.

2.5 Disclosure of your personal information

2.5.1 We may disclose your personal information to third parties who are involved in the delivery of products and services to you such as trusted service providers (sub-contractors).

2.5.2 Where Automatrix discloses your personal information to any third party, the latter will be obliged to use that personal information for the reasons and purposes it was disclosed for. To this end, we have agreements in place with these third parties to ensure this and to ensure an adequate level of security and confidentiality for your personal information.



2.5.3 Automatrix may be obliged to disclose your personal information where we have a duty to disclose in terms of law or where we believe it is necessary to protect our rights.

2.6 Trans-border/Cross border flows of personal information

Section 72 of POPIA provides that personal information may only be transferred out of the Republic of South Africa if certain conditions are satisfied. Automatrix currently has no planned transborder flows of personal information. Insofar as the transborder flow of Personal Information may become applicable in future, Automatrix will comply with the conditions set out in section 72 of POPIA.

2.7 General description of information security measures

2.7.1 Automatrix takes reasonable and appropriate technical and organisational measures to ensure that personal information is kept secure and is protected against unauthorised or unlawful processing, accidental loss, destruction or damage, alteration disclosure or access. We contractually require that service providers who handle your personal information for us do the same.

2.7.2 Automatrix, on a regular basis, reviews the security controls and related to processes to ensure that personal information is secure.

## HOW TO REQUEST ACCESS TO A RECORD

2.8 To request a record in terms of PAIA, the requestor must complete the prescribed form attached to this manual as **Annexure A**. This request must be sent to the Information Officer at the addresses provided at paragraph 1.6.

2.9 For POPIA-related requests to object to the processing of personal information, correct or delete personal information, the request must be made in writing on the applicable prescribed **Form 1** (objection) or **Form 2** (correction or deletion), which are attached to this Manual as **Annexure B**.

2.10 The requestor must provide sufficient detail to enable the Information Officer to identify the record(s) requested and the requestor. The requestor must indicate which form of access is required, identify the right that he/she is seeking to exercise or protect and provide an explanation of why the requested record is required for the exercise or protection of that right.

2.11 If the request is made on behalf of another person, the requestor must submit proof of the capacity in which the requestor is making the request, to the reasonable satisfaction of the Information Officer.

2.12 PAIA makes provision for certain grounds upon which a request for access to information must be refused. On this basis, the Information Officer will make a decision whether or not to grant a request for access to information.

## **PAYMENT OF FEES**

2.13 PAIA provides for two types of fees, namely –

2.13.1 a request fee, which will be a standard non-refundable administration fee, payable prior to the request being considered; and

2.13.2 an access fee, payable when access is granted which must be calculated by taking into account reproduction costs, search and preparation time and cost, as well as postal costs.

2.14 Subsequent to a request being made, the Information Officer, shall by notice require the requester, excluding personal requester, to pay the prescribed request fee (if any), before further processing of the request.

2.15 If the search for and preparation for disclosure of the record has been made, including arrangement to make it available in the requested form, requires more than the hours prescribed in the regulations for this purpose, Automatrix will request the requester to pay as a deposit the prescribed portion of the access fee which would be payable if the request is granted.

2.16 Automatrix may withhold a record until the requester has paid the fees as indicated in **Annexure C**.

2.17 A requester whose request has been granted must pay the applicable access fee for reproduction, search, preparation and for any time reasonably required in excess of the prescribed hours to search for and prepare the record for disclosure including making arrangements to make it available in the request form.

2.18 In terms of POPIA, a data subject has the right to request Automatrix to confirm, free of charge, whether or it holds personal information about the data subject and request from Automatrix the record or a description of the personal information held, including information about the identity of all third parties, or categories of third parties, who have, or have had, access to the information.

- 2.19 POPIA further provides that where the data subject is required to pay a fee for services provided to them, Automatrix must provide the data subject with a written estimate of the payable amount before providing the service and may require that the requestor pay a deposit for all or part of the fee.

#### **APPLICABLE TIME-PERIODS**

- 2.20 Automatrix will inform the requester within 30 days after receipt of the request of its decision whether or not to grant the request.
- 2.21 The 30 day period may be extended by a further period of not more than 30 days if the request is for a large number of records or requires a search through a large number of records and compliance with the original period would unreasonably interfere with the activities of Automatrix or the records are not located at Automatrix.

#### **OUTCOME OF THE REQUEST (GRANTING OR REFUSING)**

Should the request be refused, the notice will state adequate reasons for the refusal, including the provisions of the PAIA relied upon; and that the requester may lodge an application with a Court against the refusal of the request.

#### **GROUND FOR REFUSAL OF ACCESS TO RECORDS**

- 2.22 In terms of Section 62 to 69 of PAIA access granted to a record may be refused on one or more of the following grounds –
- 2.22.1 protection of privacy to a third party who is a natural person;
  - 2.22.2 protection of the commercial information of a third party;
  - 2.22.3 protection of certain confidential information of a third person;
  - 2.22.4 protection of the safety of individuals and the protection of property;
  - 2.22.5 protection of records privileged from production and legal proceedings;
  - 2.22.6 the commercial information of Automatrix;
  - 2.22.7 the protection of research information of a third party.

2.23 Despite any provisions of PAIA, a request must be granted if the disclosure of the record would reveal evidence of substantial contravention of, or failure to comply with, the law or imminent and serious public safety or environment risk, and the public interest in the disclosure of the record clearly outweighs the harm contemplated (section 70 of PAIA).

#### **REMEDIES FOR REFUSAL**

Should the requester be dissatisfied with the Information Officer's decision to refuse access, that person may within 30 days after notification of the refusal apply to a Court for the appropriate relief.

#### **AVAILABILITY OF THE MANUAL**

#### **UPDATING OF THIS MANUAL**

This manual will be reviewed and updated, if necessary, on a periodic basis but no less than once each year.
